Step 1

Step 2

Step 3
Service Request Proposal provided by Lead Partner
This sets out the brief, scope of services and fees.

Step 4

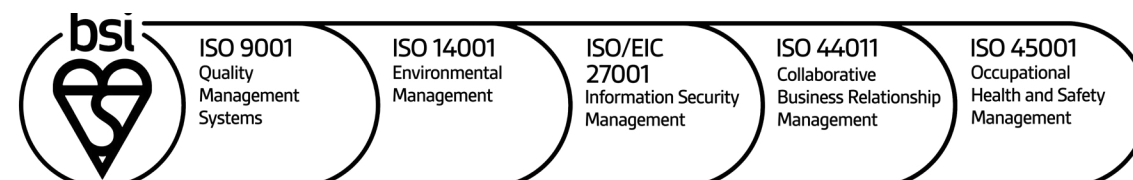
